As you know, Proposition 14 created the Treatments and Cures Accessibility and Affordability Working Group (AAWG) to recommend policies and programs to the Board to enhance access to, and the affordability of, treatments and cures arising from CIRM-funded research for California patients. The AAWG is composed of 17 members: seven members of the Board, including the Chair and Vice Chair, and 10 outside experts. Pursuant to Health & Safety Code section 125290.75, the Chair and Vice Chair of the Board are required to nominate members of the AAWG for approval by the Board.

I now wish to nominate Elizabeth Boileau who fills the seat for a representative from a hospital in California that is participating in stem cell clinical trials or FDA approved stem cell or genetic therapy.

Elizabeth Boileau

Elizabeth "Liz" Boileau is an accomplished healthcare leader with 34 years of professional experience in managed care/payer strategy, business development, and value-based contracting strategy; working for both health plans and health systems.

Liz began her healthcare career at PacifiCare of Oregon, helping to launch the Secure Horizons sales team in the Oregon market. In the late 1990s, Liz made the move into Provider Network Management and Managed Care Contracting at PacifiCare, overseeing multiple medical group and hospital incorporating traditional fee for service and capitation relationships. From PacifiCare, Liz moved into the provider realm overseeing managed care contracting as well as assisting in operating a small, community-based Managed Medicaid Plan for Tuality Community Hospital. In this role, Liz gained valuable experience working directly with the State of Oregon Medicaid program and taking on the liaison role between the state and the Oregon Managed Medicaid plans as chair of the Contract Language subcommittee. In 2004, she began her 20+ years of working in Academic Medical Center Managed Care Contracting at Oregon Health & Science University (OHSU). Liz's responsibilities increased over her 19 years at OHSU from Manage Care Contract Manager to Senior Director of Payor Strategies, where she helped lead OHSU's entry into value-based contracting with both Commercial and Medicare Advantage payors.

Currently, Liz is the Executive Director of Managed Care and Pharmacy Contracting for UC Davis Health, a role she has held since the fall of 2023. In this role, Liz focuses on the development of key payer strategies across Commercial, Medicare and Medicaid programs, building sustainable value-based programs across all payor types, strengthening key internal relationships in support of the UC Davis Health mission and clinical strategy, and representing UC Davis Health contracting within the UC Health system.

Liz is an active member of the Northern California Chapter of HFMA and was previously an active Oregon HFMA member for 15 years. Liz is a proud graduate of Gonzaga University. Liz lives in Sacramento and is enjoying all the outdoor activities offered by the sunny California climate.
